
#### ADDENDUM #1

This document includes requirements that clarify or supersede portions of the <u>Request for</u> <u>Prequalification</u> for the Butte Regional Transit Operations Center Project. This Addendum is a Contract Document.

- A. This Addendum adds to the <u>Request for Prequalification</u> by revising the requirements of Part III -PREQUALIFICATION PROCESS, Item C - Prequalification Due Date as referenced on page 5 of 29, to read as follows;
  - C. Prequalification Due Date:

Please complete all parts of prequalification and submit 1 unbound original with attachments and 10 bound copies with attachments and one (1) CD-R including a PDF copy of the prequalification package. Applicants need only include one (1) copy of the required financial statements in the unbound original. Please place the financial statements in a separate sealed envelope with the unbound original and clearly mark on the envelope with your firm name and **"Financial Statements – Prequalification for B Licensed Contractors for the Butte Regional Transit Operations Center project."** Please tab all sections of the prequalification questionnaire according to the table of contents. Prequalification submittals must be marked clearly on the envelope with your firm name and **"Prequalification for B Licensed Contractors Center"**. Contractors for the BCAG Butte Regional Transit Operations Center". Contractors' prequalification packages must be received by the Owner <u>no latter the 2:00pm on Friday May 9, 2014</u>.

- B. This Addendum adds to the <u>Request for Prequalification</u> by revising the requirements of PART I, COMPANY CONTACT INFORMATION, DECLARATION and AFFIDAVIT as referenced on page 8 of 29. Include the attached <u>ACKNOWLEDGEMENT OF ADDENDA</u> following <u>Attachment 8</u> of the Request for Prequalification in your response.
- C. This Addendum adds to the <u>Request for Prequalification</u> by revising the requirements of PART II, ESSENTIAL REQUIREMENTS FOR PREQUALIFICATION, as referenced on page 9 of 29. Question #12 has been revised to make reference to projects currently under construction or completed within the last 10 years, with a lessor value of \$10 million, to read as follows;



- D. This Addendum adds to the <u>Request for Prequalification</u> by revising the requirements of PART II, ESSENTIAL REQUIREMENTS FOR PREQUALIFICATION, as referenced on page 9 of 29. Question #13 has been revised to make reference to projects currently under construction or completed within the last 10 years, which are expect to or have achieved LEED Certified level, to read as follows;
  - Has your firm and/or any firm identified in Part III (A) contracted for or completed construction of at least two (2) projects for public entities (federal, state, county or city) within the last ten (10) years which have or are expected to achieve a *LEED Certified* or better rating from the United States Green Building Council ("USGBC")?

- E. Pursuant to the <u>PROJECT INFORMATION AND RFP INSTRUCTIONS</u>, <u>Section III</u> <u>PREQUALIFICATION PROCESS</u>, Item D Prequalification Questions, General Contractors are required to submit any questions regarding the <u>Request for Prequalification</u> in writing no later than <u>4 P.M. 4 calendar days prior to the due date</u>. The following is a list of the questions that have been submitted in writing to-date. Answers are provided.
  - The beginning of Part II states that if any of the answers to questions 11-13 are answered "no" then the Contractor will be disqualified. However, question 11 asks about convictions. Can you clarify that you will not, in fact, disqualify a Contractor for answering "no" to question 11? Answer: The prequalification form has been revised to reflect the correct response to the question and the actions taken by the Owner to review the statements.
