The following minutes are a summary of the SSTAC meeting.

The Social Services Transportation Advisory Council (SSTAC) of the Butte County Association of Governments (BCAG) was held at the BCAG office on May 8, 2019, located at 326 Huss Drive, Suite 150 in Chico, California.

Item #1 - Introductions

The meeting started off with each person present stating their name and agency, if any, they are affiliated with.

Item #2 – SSTAC Minutes – April 27, 2017 Minutes

No comments were received. On motion by Councilmember Wise, seconded by Councilmember Schroeder, the Minutes were unanimously approved.

Item #3 – Unmet Transit Needs Assessment and Findings for FY 2018/19

Staff explained the Unmet Transit Needs annual process and stated that public comments are taken throughout the year. Public meetings were held in Oroville, Chico, Gridley and Paradise. Although there are unmet transit needs, there were no unmet transit needs that were found under definition to be reasonable to meet. Therefore, no findings were made.

Councilmember Schroeder commented that her staff and bus guides like the Double Map app. Sometimes the bus is shown going in the opposite direction though.

It was mentioned that Route 2 still has north/south not inbound/outbound and has been running very late. Staff stated that if you punch in the route number in the schedule it will give an estimated arrival time. Tracker will be phased out and replaced completely by Double Map.

Rio Lindo slows down Route 2 and has unnecessary stopping and talking; if it went in the other direction, it might stop unnecessary talking and stops.

Councilmember De Los Santos said there were no comment cards on the Oroville routes.

Staff mentioned that the ridership to the Chico airport is not meeting the 10% rural farebox recovery needed even though it is an unmet need. If the ridership doesn't at least double, the route will not be incorporated into the B-Line schedule.

Councilmember Schroeder suggested going to the businesses out at the airport to offer services to learn to read the bus schedule; they have done that with the Torres Shelter, the College and the Jesus Center.

Councilmember Jones suggested dispatchers make announcements in Double Map if there are delays or accidents in real-time for those passengers signed up to receive messages. Staff will look into this.

Councilmember Jones asked how the farebox recovery ratio is going for urban and rural service. Staff answered that the urban is 21-22% and rural is 16-17% which easily makes the ratio.

Staff mentioned that they have wanted to integrate GPS with the fareboxes to be able to track when a passenger gets on the bus and what the fare is. Once this information is obtainable, it will help with the re-vamping of Oroville routes.

Councilmember Schroeder said that the bus stop at Walmart in Oroville backs up traffic where the cars can't go around the bus. Staff said they tried to work with Walmart of where to locate the bus stop and Walmart wanted the stop there and not another location.

It was mentioned that Reggie and Ken continue to be the best drivers.

On motion by Councilmember Jones, seconded by Councilmember Fichter, the Minutes were unanimously approved.

Item #4 - Other Items for Discussion

Councilmember Connors said that she had trouble getting a hold of staff through the BCAG phone system and had to send an email. Staff said they had a new phone system and are troubleshooting the problem.

A discussion of credit card fees for the purchase of bus tickets was brought up. Councilmember Jones said that some county departments are going to start paying the fee for credit card transactions.

The Paradise Transit Center (PTC) was generally discussed. The location will be across from Depot Park and there will not be any bathrooms needed to be built. General discussion took place regarding the problems with homeless people living in the bathrooms and smoking at the other transit centers. Staff said they are working the cities and police departments to clean up the transit centers.

No other items were presented.

UNMET TRANSIT NEEDS ASSESSMENT AND FINDINGS FOR FY 2017/18

ISSUE: BCAG is required to prepare the Unmet Transit Needs Assessment each year as the administrator of Transportation Development Act (TDA) funds for Butte County.

DISCUSSION: Each year, BCAG must identify any unmet public transit needs that may exist in Butte County in order to receive state funding. If unmet transit needs are found, a further determination must be made as to whether those needs are reasonable to meet. All unmet transit needs that are reasonable to meet must be met before TDA funds are expended for non-transit uses, such as streets and roads.

Testimony has been collected through a series of public meetings that were held during March and compiled into an analysis report. Three public meetings are held in Chico, Gridley and Oroville before the final public hearing before the BCAG Board of Directors. Normally a public meeting is also scheduled for Paradise, however, after the Camp Fire that was combined with the Chico meeting. Attached is the Draft *Unmet Transit Needs Assessment - 2019/2020*. The Assessment examines transit dependent groups, adequacy of existing transit services, a detailed summary of the public testimony received during this year's outreach process, and staff's analysis of whether the testimony meets the definitions of unmet transit needs and reasonable to meet.

If the Board determines there are unmet transit needs that are reasonable to meet, the affected jurisdiction must satisfy those needs before any TDA funds may be expended for non-transit purposes.

Based on the testimony and analysis with the adopted definitions of unmet transit needs and reasonable to meet, the BCAG Board of Directors is **required** to make one of three findings:

- 1. There are no unmet transit needs,
- 2. There are no unmet transit needs that are reasonable to meet.
- 3. There are unmet transit needs, including needs that are reasonable to meet.

Findings for the 2019/20 Fiscal Year

Based on the testimony received and on staff's analysis with the adopted definitions of unmet transit needs and reasonable to meet, BCAG staff is recommending that the following finding be made by the BCAG Board of Directors:

There are no unmet transit needs that are reasonable to meet.

This recommendation will be presented to the BCAG Board of Directors at the May 24, 2018 Board meeting.

STAFF RECOMMENDATION: Staff requests the Social Services Transportation Advisory Council support staff's recommendation to the BCAG Board of Directors to accept the Unmet Transit Needs Assessment for the 2019/20 fiscal year and find that there are no unmet transit needs that are reasonable to meet.
