STATION 2 WHAT IS BCAG?

The Butte County Association of Governments is the federally designated Metropolitan Planning Organization (MPO), and the state designated Regional Transportation Planning Agency (RTPA) for Butte County.

BCAG BOARD OF DIRECTORS:

The Board of Directors includes one representative from each of Butte County's five incorporated cities and town, and all five representatives of the Butte County Board of Supervisors.

BCAG's RESPONSIBILITIES

- ✓ Secure state and federal transportation funds available to the region, and ensure timely delivery of transportation projects and programs within the region.
- Responsible for preparation of all regional transportation plans and programming documents necessary to secure state and federal funding
- Administrator of B-Line Transit System
- Conduct planning projects that mutually benefit cities, town and county

STATION 3 PURPOSE OF REGIONAL TRANSPORTATION PLAN

The RTP

- 1. Serve as a foundation for programming of projects within the region (Butte County).
- 2. Meet State and Federal requirements for other planning and funding activities.
- 3. Serve as a foundation for:

Federal Transportation Improvement Program (FTIP)
Regional Transportation Improvement Program (RTIP)
Interregional Transportation Improvement Program (ITIP)

The RTP has three main components:

- 1. Policy Element Reflects the mobility goals, policies and objectives of the region.
- 2. Action Element Identifies the programs and actions to implement the RTP for each mode of transportation.
- 3. Financial Element Summarizes the costs of implementing the projects in the RTP.
