Item #3 – 2024 Regional Transportation Improvement Program (RTIP) Development and Schedule

Staff provided an overview of the 2024 RTIP including components, funding, and emphasis areas. Staff reviewed each of the requirements for all projects including:

- 1. Inclusion of project in the adopted RTP/SCS
- 2. Project Study Report or equivalent
- 3. Performance Metrics
- 4. Electronic Project Programming Request (ePPR) form developed in CalSmart

Staff indicated that that the ePPRs should be kept as a draft. Staff presented the projects received for programming consideration. Projects received by BCAG include:

Staff indicated that the project were being reviewed and would be presented to the BCAG Board on September 28, 2023, for their awareness and input. Staff encouraged project sponsors to attend the Board meeting should the Board have any specific questions.

Staff stated that draft recommendations for funding would be presented at the October 5th BCAG TAC meeting.

Item #4 – 2024 Regional Transportation Plan / Sustainable Communities Strategy Development

Staff provided an overview of the RTP/SCS process and relevance to BCAG's planning and programming activities. Staff informed the committee that Rincon Consultants Inc. have been retained to prepare the environmental impact report for the RTP/SCS. Staff indicated that a key component to the RTP/SCS is to update the project lists in the 2020 document. The stated that in order to report to the Air Resources Board and to prepare the updated list, certain questions needed to be answered for the 2024 update including:

- 1. Has the project been completed since the 2020 RTP/SCS has been adopted / December 2020?
- 2. Is the project a carryover indicating that it has not been completed yet?
- 3. Are there changes to the scope, description, name, updated costs/schedule or emissions analysis year (for capacity increasing projects)?
- 4. Are the performance metrics reflected accurately for the project?
- 5. What new projects need to be included in the 2024 RTP/SCS?

Staff informed the committee that individual meetings were taking place for the project list update. Once compiled, the entire project list would be presented to the committee.

Item #5 – Active Transportation Program – Cycle 7

Staff informed the committee of the upcoming ATP Cycle 7 and that BCAG was hosting the 2025 ATP Kickoff Workshop on September 14th in the BCAG Board room. Staff stated that Cycle 7 would be funded at approximately \$550 million whereas Cycle 6 was funded at \$1.5 billion, nearly 3 times as much. As such, staff expects the funding cutoff to be near a 96 to be funded. Staff strongly encouraged applicants to take advantage of the workshops being held and consult BCAG to strategize and prepare Cycle 7 applications.

2024 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM (RTIP) - DRAFT RECOMMENDATIONS

PREPARED BY: Iván Garcia, Programming Director

ISSUE: BCAG is required to prepare and adopt a Regional Transportation Improvement Program (RTIP) by December 15, 2023, for the 2024 State Transportation Improvement Program (STIP). BCAG issued a "call for projects" on July 10, 2023 for new programming considerations.

DISCUSSION: The purpose of the RTIP is to identify programming recommendations for the State Transportation Improvement Program (STIP). The 2024 STIP will cover the next five fiscal years beginning July 1, 2024 (FYs 24/25-28/29). The STIP is adopted by the California Transportation Commission (CTC) and is comprised of two components including the Regional Improvement Program and Interregional Improvement Program. The fund estimate for BCAG's RTIP as provided by the CTC is \$8,433,000

In addition, staff has evaluated each project in accordance with the adopted STIP guidelines and the priorities established by Climate Action Plan for Transportation Infrastructure (CAPTI).

Four projects are recommended for RTIP programming and five (5) projects are recommended to be considered for other federal funds programmed by BCAG. One (1) project is not recommended for programming. A summary is provided in the following table on page 2.

Staff will discuss the project recommendations in detail at the committee meeting. While the recommendation is above the Fund Estimate provided, the STIP guidelines enable a small region like BCAG to make a recommendation up to 200% of its target. BCAG may be consulted by the CTC to make funding adjustments to financially constrain the STIP after all statewide RTIPs and Caltrans' Interregional Transportation Improvement Program (ITIP) have been submitted.

The following agenda item will discuss the Carbon Reduction Program (CRP) and the Congestion Mitigation and Air Quality Program (CMAQ) for which some of the projects identified in the table may be considered for future federal funds programmed by BCAG.

Staff is not recommending the SR 99 Southgate Intersection Improvements Project by the City of Chico in this programming cycle due to financial constraints.

These project recommendations will be presented to the BCAG Board for review and comment at the October 26, 2023, Board meeting. Pending input from the BCAG Board, staff will then prepare a complete RTIP document for review and comment. A public workshop will be scheduled after the October 26, 2023, Board meeting.

Project location maps for the projects submitted for programming consideration have been attached.








Vicinity Map






Project Site

Oroville Project Location Map - Washing Ave. Complete Streets Project



Oroville Project location Map - Table Mountain Blvd. Complete Streets Project





CARBON REDUCTION PROGRAM & CONGESTION MITIGATION AND AIR QUALITY PROGRAMS

PREPARED BY: Ivan Garcia, Programming Director

ISSUE: BCAG is able to program new Carbon Reduction Program and Congestion Mitigation and Air Quality Program projects.

CARBON REDUCTION PROGRAM: The Infrastructure Investment and Jobs Act (IIJA) created the Carbon Reduction Program (CRP) to provide federal funding to projects that decrease transportation emissions which are defined as the carbon dioxide (CO2) emissions that result from on-road, highway sources. California will receive annual apportionments of CRP over the five-year period of IIJA. The apportionments are split, with 65% as Local CRP and 35% as State CRP. Both Local and State CRP funds must be invested in alignment with the Carbon Reduction Strategy (CRS).

Caltrans has already indicated that their CRP funds will be programmed through the State Highways Operation and Protection Program (SHOPP) on projects that convert existing lanes to priced managed lanes. Caltrans has stated that converting to priced managed lanes regulates demand for vehicle trips, reduces VMT, reduces carbon emissions, and can generate revenue for other low-carbon transportation projects.

The CRS outlines how California will spend its CRP dollars on reducing transportation carbon emissions. California's CRS focuses on the "Three Pillars":

Three Pillars:

- 1. Zero-emission vehicles and infrastructure.
- 2. Active transportation, and
- 3. Rail and transit.

BCAG has received apportionments for the IIJA 5-year period. It is not known if this funding will continue in the next reauthorization bill.

The process to program new projects is like the Congestion Mitigation and Air Quality Program. Projects are programmed in the Federal Transportation Improvement Program (FTIP) and administered through Caltrans Local Assistance. All projects must follow the federal-aid process.

CONGESTION MITIGATION AND AIR QUALITY PROGRAM: The purpose of the Congestion Mitigation and Air Quality (CMAQ) Program is to fund transportation projects or programs that will contribute to attainment or maintenance of the National Ambient Air Quality Standards (NAAQS) for ozone, carbon monoxide or particulate matter.

Many types of projects are eligible under the CMAQ program including electric vehicles and charging stations, diesel engine replacements and retrofits, transit improvements, bicycle and pedestrian facilities, shared micromobility projects including shared scooter systems, and more. In addition to improving air quality and reducing congestion, CMAQ projects can improve equitable access to transportation services, improve safety, and promote application of new and emerging technologies. These types of projects further the goals that are in alignment with the CRP program, CAPTI and BCAG's RTP/SCS.

Apportionments for the CMAQ program are provided by Caltrans. In addition, BCAG has the flexibility to borrow apportionments from other regions who may not be ready to deliver a project or has run into project delays. The following apportionments do not include projects already programmed in the current FTIP. Those projects would count against the programming capacity. Staff will discuss this in more detail at the committee meeting.

California Local Technical Assistance Program Sustainable Engineering Training Academy Series

On Thursday, September 14, 2023, the California Local Technical Assistance Program (**CALTAP**) hosted a training on Fugitive Dust Mitigation as part of their Sustainable Engineering Training Academy (**SETA**) series. The following were high-level key points taken from the training:

- Dust output from demolition and construction on unpaved roads may cause and/or worsen existing asthma and cancer.
- A spreadsheet was provided to calculate construction dust emissions based on equipment used, type of activity, vehicle miles traveled, duration, road conditions, applied architectural coating, and paving used.
- Mitigating factors included how often to water, limiting traffic speeds, and using tarps and other temporary coverings on dirt, debris, and storage piles at the construction site.
- Contractors, public agencies, and Tribes may save money by using reclaimed water, blast cannons, and irrigation lines.
- Industry experts presented several case studies on dust mitigation for large regional construction projects.
